The cost for food truck/trailer space at the Maui STREET Market is **\$2,100 per month + 4.167% GET state tax + a security deposit of \$2,100**. Upon approval of your application, the Maui Food Technology Center will email you a Maui STREET Market Lease Agreement to sign and payment information. We accept checks, credit cards and Venmo payments.

## FOOD TRUCK/TRAILER OPERATOR REQUIREMENTS

In order to participate in the Maui STREET Market, you must have the following:

- Valid Food Establishment Permit and Green Placard issued by the Hawaii State Department of Health.
- A \$1 million liability insurance policy and \$2 million aggregate per occurrence and to name Maui Food Technology Center and Weinberg Foundation as additionally insured.

## HOLD HARMLESS AGREEMENT

I, the Vendor, hereby agree to indemnify, defend, and hold Maui STREET Market, Maui Food Technology Center, Weinberg Foundation, and all of their employees, agents, representatives and volunteers harmless from and against any and all claims, liabilities, losses, damages, costs, expenses (including attorney's fees), judgments and penalties arising out of (i) any third party claims concerning alleged food product concerns or merchandise manufactured, distributed, provided and/or sold by the Vendor; (ii) any act or omission to act of the Vendor, its employees, servants, and agents. I understand the Maui STREET Market, Maui Food Technology Center, Weinberg Foundation and its agents reserve the right to remove any vendors that they deem inappropriate to the Maui STREET Market. I acknowledge failure to comply with the standards of being "suitable for all ages" may result in my removal from the Market and jeopardize my participation in future events. I understand that there are no refunds or rain checks due to inclement weather. In consideration of the MFTC's acceptance of my application, I agree to accept all decisions of the Maui STREET Market's Organizing Committee as final. I agree to allow the Maui STREET Market use of promotional materials, as well as photographs and videotapes taken of me, my staff, volunteers and operation during the Maui STREET Market, for purposes of promoting the Maui STREET Market this year and in future years. I also agree to allow the Maui STREET Market to release my name to the public for promotion. I understand that Maui Food Technology Center and the Maui STREET Market does not carry insurance to cover my personal property, merchandise, product, or equipment and that I store and present my vehicle, products, merchandise and equipment at my own risk.
